Mission Statement:

At Glebe School we believe in an ethos that values the whole child. We strive to enable all children to achieve their full potential academically, socially and emotionally.

Aims

Our school aims to meet its obligations under the public sector equality duty by having due regard to the need to:

Roles and responsibilities

The governing board will:

- Ensure that the equality information and objectives as set out in this statement are published and communicated throughout the school, including to staff, pupils and parents, and that they are reviewed and updated at least once every four years and this will be minuted by the clerk of the governing body;
- Delegate responsibility for monitoring the achievement of the objectives on a daily basis to the Head teacher;

- At least one member will attend appropriate equality and diversity training;
- Ensure they're familiar with all relevant legislation and the contents of this document.

The Head teacher will:

- Promote knowledge and understanding of the equality objectives amongst staff and pupils;
- Monitor success in achieving the objectives and report back to governors.

Have "due regard" when making a decision or taking an action to whether it may have particular implications for people with particular protected characteristics

All school staff are expected to have regard to this document and to work to achieve the objectives as set out in this document.

Eliminating discrimination

The school is aware of its obligations under the Equality Act 2010 and complies with non-discrimination provisions.

Where relevant, our policies include reference to the importance of avoiding discrimination and other prohibited conduct.

Staff and governors are regularly reminded of their responsibilities under the Equality Act, for example during meetings.

New staff receive training on the Equality Act as part of their induction and all staff receive refresher training.

Advancing equality of opportunity

As set out in the DFE guidance on the Equality Act, the school aims to advance equality of opportunity by:

- Removing or minimising disadvantages suffered by people which are connected to a particular characteristic they have (e.g. pupils with disabilities, or gay pupils who are being subjected to homophobic bullying);
- Taking steps to meet the particular needs of people who have a particular characteristic;
- Encouraging people who have a particular characteristic to participate fully in any activities (e.g. encouraging all pupils to be involved in the full range of extra-curricular clubs)

In fulfilling this aspect of the duty, the school will:

- Publish attainment data each academic year showing how pupils in different social groupings perform;
- Analyse the above data to determine strengths and areas for improvement, implement actions in response and publish this information;
- Make evidence available identifying improvements for specific groups (e.g. declines in incidents of homophobic or transphobic bullying);

Publish further data about any issues associated with particular protected characteristics, identifying any issues which could affect our own pupils

Fostering good relations

The school aims to foster good relations between those who share a protected characteristic and those who do not share it by:

- Promoting tolerance, friendship and understanding of a range of religions and cultures through different aspects of our curriculum. This includes teaching in Religious Education (R.E); Personal, Social, Health education (P.S.H.E); Relationships, Social and Health Education (R.S.H.E) but also activities in other curriculum areas. For example, as part of teaching and learning in English/reading, pupils will be introduced to literature from a range of cultures;
- Promoting British values, which we refer to as "Shared Values", through assemblies and classwork, such as: democracy, the rule of law, individual liberty and mutual respect / tolerance of those with different faiths and beliefs;
- Holding assemblies dealing with relevant issues. Pupils will be encouraged to take a lead in such assemblies and we will also invite external speakers to contribute;
- Working with our local community. This includes inviting leaders of local faith groups to speak at assemblies, and organising school trips and activities based around the local community;
- Encouraging and implementing initiatives to deal with tensions between different groups of pupils within the school. For example, our school council has representatives from different year groups and is formed of pupils from a range of backgrounds. All pupils are encouraged to participate in the school's activities, such as sports clubs. We also work with parents to promote knowledge and understanding of different cultures.

Responsibility

We believe that promoting equality is the whole school's responsibility.

The school endeavours to:

- a) Eliminate unlawful discrimination and other conduct that is prohibited by the Act;
- b) Advance equality of opportunity between people who share a protected characteristic and people who do not;
- c) Foster good relations between people who share a protected characteristic and people who do not.

To this end, measures adopted by the school include:

- (a) For pupils - implementation of policies including equal opportunities, special needs and/or disabilities, behaviour and anti-bullying;
- (b) Ensuring that the curriculum includes P.S.H.E, R.S.H.E, R.E and other elements that promote friendship and understanding about cultures and lifestyles;
- (d) Employing specialist staff to support pupils with special needs or disabilities, and implementing the school's disability access plan;
- (e) The monitoring of the welfare of pupils, with intervention and support where required;
- (f) taking steps to meet the particular needs of pupils that have a protected characteristic.

Equality objectives

Objective 1) To monitor and promote the involvement of all groups of students in the extra-curricular life of the school, including leadership opportunities

Objective 2) To actively close gaps in attainment and achievement between students and all groups of students; especially boys, students eligible for free-school meals, students with special educational needs and disabilities, looked after children and students from minority ethnic groups

Objective 3) To actively explore and address the reasons behind persistent absenteeism for all pupils but especially those who are pupil premium, have a social worker and/or have special educational needs.


Monitoring arrangements
